### Ingredients

### Directions

Apply Jungle Jake<sup>®</sup> RTU to the surface to be cleaned. Pre-spot and/or pre-soak if necessary. Use a non-abrasive brush or cloth to scrub heavily deposited surfaces. Rinse. For stubborn stains and deposits, repeat procedure if necessary.
